IT IS ORDERED pursuant to A.R.S. § 12-1809:

THAT the Defendant shall not:
harass, annoy, threaten, assault follow or go upon
Plaintiff's residence. you shall be, have any contact
with Plaintiff, directly or indirectly, including
telephonic communication
